STATUTORY DECLARATION ON RIGHT TO INFORMATION (RTI) ACT

UNDER SECTION 4(1) (B) OF RTI ACT 2005

The **Right to Information Act, 2005 (22 of 2005)** has been enacted by the Parliament and has come into force from 15 June, 2005. This Act provides right to information for citizens to secure access to information under the control of public authorities in order to promote transparency and accountability in the working of every public authority. According to UGC guidelines all Universities and Colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled or substantially financed directly or indirectly by funds provided by the Government shall come within the purview of a Public Authority under this Act. Hence **Rashtriya Shikshan Prasarak Mandal Beed's Lokmanya Tilak Mahavidyalaya Wadwani Tq. Wadwani Dist. Beed – 431144 Maharashtra**. The statutory declaration is displayed on College website. Our college is a "College of co-education" which is registered under Society Act by Govt. of Maharashtra. The College has a Governing Body which runs as per rules and regulations made by the Govt. of Maharashtra from time to time.

The College has established the statutory bodies and various committees and cells which come under section 4(1) (b) of RTI Act 2005.
